

## Station Casinos Great Giveaway Football Contest

**Palace Station - Boulder Station - Texas Station - Sunset Station - Santa Fe Station –  
Green Valley Ranch Station – Red Rock Station – Aliante Station – Fiesta Rancho -  
Fiesta Henderson – Wild Wild West – Gold Rush – Barley’s – Wildfire Casino Boulder –  
Wildfire Casino Rancho – Wildfire Casino and Lanes  
Official Rules – 2009/2010 Season**

1. All contestants must be twenty-one (21) years of age or older, have a Station Casinos Boarding Pass Card, Amigo Card or WildCard and must present valid identification to participate in the Great Giveaway Football Contest
2. There will be a twenty five dollar (\$25) fee per entry. Contestants may also use Boarding Pass points, Amigo Points, WildCard Points or Station Bucks, Amigo Bucks or Wildfire Gaming Bucks for payment or partial payment of entries.
3. Each contestant is limited to a maximum of two (2) purchased entries. Contestants who purchase two (2) entries will receive one (1) free bonus entry, for a total of three (3) entries. **Contestants may have a maximum of three (3) total entries (two (2) purchased entries and one (1) free bonus entry per contestant).** Entries may also be awarded utilizing other methods at the sole discretion of management of Station Casinos, Inc and/or any of its subsidiaries (Management.) No refund of entry fees will be allowed except in accordance with rules described in paragraph four (4) below and elsewhere in these official rules.
4. Any contestant who purchased his or her entry or entries (comped entries awarded by Management are not eligible for refunds) will receive his or her entry fee back at the end of the season if the contestant (i) has competed in all seventeen (17) weeks of the contest on all of the contestant’s entries, and (ii) did not win any Weekly prizes or End-of-Contest prizes. For example, if a contestant has three (3) total entries into the contest, in order to qualify for a refund of such contestant’s entry fees, the contestant must (i) compete in all seventeen (17) weeks of the contest on all three (3) of the contestant’s entries, and (ii) not have won any Weekly prizes or End-of-Contest prizes on any of the contestant’s entries. Also for example, if a contestant only competes in all seventeen weeks (17) of the contest on two (2) of three (3) entries, or if the contestant wins a Weekly prize or an end of season prize with respect to any entry, the contestant will not qualify for a refund of any entry fee. Purchased entry fees will be refunded to qualifying contestants in the form of Free Slot Play at the end of the season at a time and date determined by Management. Free Slot Play will be valid by swiping a qualified Boarding Pass, Amigo Card or WildCard at any My/Rewards kiosk starting **January 20, 2010**. Once Free Slot Play is accepted at the My/Rewards kiosk it will be valid for thirty (30) days. The maximum amount that can be refunded to a contestant is fifty dollars (\$50) in Free Slot Play. Free Slot Play will only be valid at the property at which a contestant purchased a Great Giveaway Football Contest entry.
5. Any contestant who purchases more than two (2) contest entries will be disqualified and ineligible for any and all prizes, or Free Slot Play. Entries are non-transferable and non-refundable except as otherwise specifically described herein. Contest cards will be available at each property's race and sports book or other location designated by Management.
6. All entries and prizes are aggregate for Palace Station, Boulder Station, Texas Station, Sunset Station, Santa Fe Station, Green Valley Ranch Station, Red Rock Station, Aliante Station, Fiesta Rancho, Fiesta Henderson, Wild Wild West, Gold Rush, Barley’s, Wildfire Casino Boulder, Wildfire Casino Rancho, and Wildfire Casino and Lanes. Contestants may enter at any location but may not purchase a total of more than two (2) entries. Aggregate shall be defined to mean that all references herein to total entries and total prizes shall consider such amounts as applicable cumulatively to all participating Station Casinos, Inc. properties inclusive of all of its subsidiaries. In no event shall references to aggregate be defined to mean that each property is to be separately considered for reference to amounts of entries or prizes.
7. Each contestant is required to make selections on every game every week that the contest is offered in order to be eligible for the End-of-Contest prizes. Each contestant is required to make selections on every game of the week in order to be eligible for the Weekly prizes. Contestants may enter “late” after the season begins until the start of the first game played in the last Pro Football 2009/2010 regular season week. **Late entries will not be eligible for**

**End-Of-Contest prizes.** Late entries will be eligible for Weekly prizes beginning the first week entered in accordance with these rules.

8. To be eligible, contestants must select all games on the Great Giveaway Football Contest card. For tiebreakers, contestants must select their best guess for the total combined score of the Monday Night Football game (without going over). In weeks that there is more than one Monday Night Football game, the last game listed on the contest card will be the tiebreaker game. In the event that there is not a Monday Night Football game, contestants must select their best guess for the total combined score of the last Sunday game listed on the contest card (without going over) that week. Each contestant must make his or her selections before the start of the first game listed on the contest card each week. Any other games in the Pro Football 17-week season not played on Sunday or Monday will not be included on the weekly contest cards nor affect the contest's outcome.
  
9. When using a kiosk, it is the contestant's sole responsibility to print a receipt of the transaction and to end the session on the kiosk by touching the "end session" button on the touch screen. If the contestant chooses to turn in a contest card at a "manned station," the contestant will receive a computer contest ticket for that week's selections. It is the contestant's sole responsibility to check the ticket for the correct contestant number and game selections before leaving the window of the "manned station." The contest card will also include the time and date when selections were made. **The contestant's official selections will be contained in the Great Giveaway Football Contest system's computer records.**
  
10. Each contestant will use his or her Boarding Pass, Amigo Card or WildCard along with a Personal Identification Number (PIN number) for any transaction relating to the Great Giveaway Football Contest. End-Of-Contest prizes will be awarded based on a contestant's selections for the entire season and Weekly prizes will be awarded based on a contestant's selections for each particular week. Contestants may make changes to their weekly selections anytime prior to the start of the first game listed on the contest card that week. Contestants may make selections up to four (4) weeks in advance only.
  
11. The total prize structure for Station Casinos Great Giveaway Football Contest:

12. All prizes must be collected in person. To collect winnings the contestant's valid photo I.D. and Boarding Pass Card, Amigo Card or WildCard must be presented in person at the property of the contestant's choice. **All prizes must be collected by March 15, 2010, or uncollected prizes shall be forfeited.**
13. If a winner chooses to take the House or the FORD F150 STX the winner is responsible for all related expenses and costs, including but not limited to, taxes, licenses, registration, title, insurance, and any and all settlement and closing costs and expenses without limitation.
14. Winners for Most Winners and Losers places 11<sup>th</sup> – 200<sup>th</sup> will receive Free Slot Play. Free Slot Play will be valid by swiping a Boarding Pass Card, Amigo Card or WildCard at any My/Rewards kiosks. Once Free Slot Play is accepted at a My/Rewards kiosk, it will be valid for thirty (30) days. If you are a winner and have additional questions please visit any Rewards Center for additional clarification. You must activate your Free Slot Play by **March 15, 2010, or it will be forfeited. Free Slot Play will only be valid at the property at which you entered the Great Giveaway Football Contest.**
15. Cancellations, changes, rescheduling and ties.
  - In the event an entire week of games is canceled, the games will not be counted in the contest and the Weekly prize money will not be awarded.
  - In order for the Weekly prizes to be awarded there must be a minimum of nine (9) games played and counted. If there are less than nine (9) games played, that week's games will not be counted for the End-Of-Contest prizes.
  - In order for the End-Of-Contest prizes to be awarded, there must be a minimum of twelve (12) weeks played and counted. Should a disruption of the Pro Football regular season occur, Station Casinos reserves the right at Management's sole discretion to substitute college games for unplayed Pro Football games.
  - In the event that any game listed in the contest card should end in a tie score the game will not be counted in the contest.
  - In the event that any game listed on the contest card should have a starting time change, but not a date change, the game will be counted in the contest.
  - In the event that any game listed on the contest card should have a date change the game will not be counted in the contest.
  - In the event that a game not listed on a contest card should have a date change that schedules the game to be played on Sunday or Monday, the game will not be counted in the contest.
16. End-Of-Contest Most Winners
  - Contestants who select the most "winners" during the contest will win the End-Of- Contest Most Winners prizes as depicted on the prize schedule. In the event of a tie for any of the End-Of-Contest Most Winners prizes, the "Tiebreaker Rules" will go into effect. The "Tiebreaker Rules" will be posted in the casino.
17. End-Of-Contest Most Losers
  - Contestants who select the most "losers" during the contest will win the End-Of- Contest Most Losers prizes as depicted on the prize schedule. In the event of a tie for any of the End-Of-Contest Most Losers prizes, the "Tiebreaker Rules" will go into effect. The "Tiebreaker Rules" will be posted in the casino.
18. End-Of-Contest Fiddle in the Middle
  - A contestant who enters a contest card every week of the Great Giveaway Football contest and has achieved a .500 record (defined as an equal number of wins and losses) will be eligible for \$200,000 in "Fiddle in the Middle" prize money. In the event of a tie for this aggregate \$200,000 prize, the prize will be distributed evenly among all contestants who finished with an equal number of wins and losses. If no contestant(s) obtains an equal number of winning and losing selections, this special prize will be distributed evenly among contestants who all have the same End-Of-Contest records closest to .500. For purposes of measuring "closest to .500," End-Of-Contest records will be considered both above and below .500 and Management shall determine, at Management's sole discretion, all winners with equally closest to .500 records.

19. Weekly Winners

- A contestant who selects the most "winners" in a week will win the FORD F-150 STX or cash prize of \$20,000.
  - If two (2) contestants tie for the most wins in a week, the tied contestant who selected the closest total combined score for that week's Monday Night Football game (or Sunday game if applicable) without going over the total combined score will win the contestant's choice of \$10,000 cash or a FORD F-150 STX. The remaining \$10,000 shall be awarded to the other tied contestant. Should there be a tie in the Monday Night Football game (or Sunday game if applicable) tiebreaker, the contestant who turned in his or her weekly picks the earliest shall win the contestant's choice of \$10,000 or a FORD F-150 STX, and the remaining \$10,000 will go to the other contestant.
  - If three (3) or more contestants tie for the most wins in a week, the tied contestant who selected the closest total combined score for that week's Monday Night Football game (or Sunday game if applicable) without going over the total combined score will win the contestant's choice of \$10,000 cash or a FORD F-150 STX. The remaining \$10,000 will be split equally between the remaining tied contestants. Should there be a tie in the Monday Night Football game (or Sunday game if applicable) tiebreaker, the contestant who turned in his or her weekly picks the earliest shall win the contestant's choice of \$10,000 or a FORD F-150 STX, and the remaining \$10,000 will be split equally between the remaining tied contestants.

20. Weekly Losers

- A contestant who selects the most "losers" in a week will win the weekly cash prize of \$10,000.
  - If two (2) contestants tie for the most losers in a week, the \$10,000 cash prize will be split equally between each tied contestant.
  - If three (3) or more contestants tie for the most losers in a week, the tied contestant who selected the closest total combined score for that week's Monday Night Football game (or Sunday game if applicable) without going over the total combined score will win \$5,000, and the remaining \$5,000 will be split equally between the remaining tied contestants. Should there be a tie in the Monday Night Football game (or Sunday game if applicable) tiebreaker, the contestant who turned in his or her weekly picks the earliest shall win \$5,000, and the remaining \$5,000 will be split equally between the remaining tied contestants.

21. A complete list of weekly winners and standings will be available each Tuesday at approximately 2:00 p.m. in the sports book areas. Payment will begin Thursday at approximately 10:00 a.m. in the Sports Book. Standings and winners' names will not be given over the telephone.

22. After the End-Of-Contest winners are announced on **January 11, 2010**, a seven (7) day waiting period will take place. At the conclusion of this waiting period, the contest will officially end. All prize winners will then be affirmed as accurately tallied by Management, and the winning contestants will be eligible to receive their prizes.

23. Team Members, including members of their immediate households, of Station Casinos, Inc., and its subsidiaries **are** eligible to participate in the Great Giveaway Football Contest, with the exception of the following Team Members who **are not** eligible to participate:

- All Team Members directly involved in the "Great Giveaway Football Contest" promotion
- All Race & Sports Book Team Members
- All Team Members holding Director level positions or above
- Any other Team Member prohibited from gambling pursuant to Station Casinos' policy on Team Member gambling

24. Management shall resolve, at Management's sole and final discretion, any dispute not covered by these official rules. Management reserves the right to modify or cancel this contest or these rules at any time and to exclude any individual from this contest at Management's sole discretion.

25. Participation in this contest constitutes the contestant's agreement to abide by the rules of this contest. Any and all taxes, fees and incidental costs and expenses without limitation are the sole responsibility of the contestant.

26. By participating in this contest each winner hereby gives permission to Station Casinos, Inc., and any of its affiliated companies to use his or her name, likeness, image, photo, etc., for promotional purposes without additional compensation.
